Training is available online at ahcccs.gov/acc. Change in health plans for AHCCCS – now called AHCCCS Complete Care (ACC) which will be physical and behavioral health integration plans. Letters will be sent out to members in June. If families do not choose a plan, one will be auto assigned to them. Families will have 31 days in July to change plan if they do not want the auto-assigned one. Health-e Arizona plus is the website to update any family changes (address, phone number, etc.). MOU with WIC. Will try to work on one for 5 years that would work for all grantees.

- Federal Reviews – Pinal/Gila and Maricopa County both received a review. Check mark/list form. Both programs did well on review and CLASS scores. It is an opportunity to share what your program is doing, and more focused on health services rather than oral health and nutrition. Staff coming out are just data collectors and cannot tell how agencies did or give out scores.

Marcela shared they had a CACFP review. Was given TA and action plans, but was told starting in October there will be no more TA. Question: What do you do with that child who comes in late and still needs breakfast? A: Still offers breakfast, but cannot claim it.

- Expulsion by Nicol Russell and Amy Kemp as it directly relates to Head Start. How does this effect what our Health Committee is working on?
Liz shared being able to identify medical concerns/conditions early on, as well as dental problems. Would like to push ADHS to require children to have a current PE and DE when entering into childcare and preschool settings.
Chrisanda asked about children not current on immunizations – does that count as an expulsion? Immies are state law and need to be excluded until they become compliant, so this would not count as an expulsion.

Health checks – staff need more training on when to send a child home. Parents need support and training on when to keep their child home from school. Recommended Caring for our Children to review when to send a child home.

- Vote for new Chairperson – Connie sent out a proposal via email. Would help if chair and co-chair could split up committee meetings. Mo and Mindy clarified that chair person should serve 1 year. Carolyn has volunteered to
