

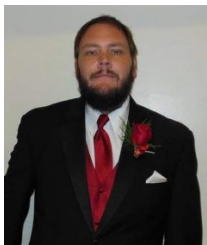
# Board of Directors Elections

### **Elections**

keeping. Ballots will be tabulated, and election results will be announced via email to the elected participant before the AZHSA August Board Meeting. Once an individual accepts the results, they will sign their Job Description and it will be sent to AZHSA Director for record keeping and they will also be seated at the AZHSA August Board meeting.
