	Key: School Districts (SD) Head Start (HS) Developmental Preschool (DP)
	1: Staff Shortages across HS and SD - If children are dually enrolled in DP and HS, some SDs don't have enough bus drivers to transport children to and from DP and HS, so children are dropping from HS and only attending DP. - Not enough therapists, therapists can't travel to non-SD sites so children drop from HS to receive IEP services at SD Sites instead - Not enough teacher and classroom assistants to open HS classrooms, children kept on waitlist until a



2: Transportation Issues

- parents don't have transportation to get children to HS programming
- parents can't leave work to pick up children from HS, don't have family members that can help with transportation

3: COVID-19

- Parents do not want in-person learning, no online option
- Referrals to AzEIP and Developmental Preschool have been down due to pandemic, that is turn means numbers are down for HS.

4: Children on IFSPs/IEPs but over-income

- Child Crisis has already uses their 10% over-income slots for this program year

5: AzEIP Providers/Staff unaware of what HS is and the placement options during the transition process out of AzEIP

- High turnover rate? Do new Service Coordinators know who their HS partners are?
- Do AzEIP providers know about new AzEIP/HS MOU?
- A few years ago the AZHSA committee created IFSP/IEP flyers for AzEIP providers and community partners.
